### About the survey

The survey we are asking you to take part in is a national survey of everyone who has recently qualified from any university or HE college in the UK. The information you provide will also be very useful to us at *university/college* to advise our current students about the opportunities that might be available to them.

Of those who obtained qualification across the UK in 2010/11, 78.8% responded to the survey. Of these, 64.4% reported that they were working and a further 10.1% were working and studying. 13.7% were undertaking further study only. 7.6% of leavers were assumed to be unemployed.
