Notes	<p>When a Student course session has ended this field must be completed to indicate the reason.</p> <p>01 'Withdrawn' indicates that the Student course session has ended due to the student leaving the reporting provider.</p> <p>02 'Interrupted' indicates that the Student course session has ended due to the student taking an agreed break in learning. Where this is returned, a subsequent Student course session does not need to be returned until the student restarts study.</p> <p>If a student takes an agreed break part way through a Student course session, this should be recorded in the SessionStatus entity, 02 should be used at the end of a Student course session.</p> <p>03 'Transferred' indicates that the student has transferred to another course delivery within the reporting provider. If the student transfers to another provider, this should be returned as '01 Withdrawn'.</p> <p>04 'Ended' should be used where the Student course session has come to its end, regardless of whether the student successfully completed the associated Course session. This would be because the end date of the associated Course session has been reached or because the student has completed all of the assessment for that Course session.</p>
